In the interest of disclosure, Mr. Tracy informed the Board that due to the regulations surrounding his salary negotiations and the way that retroactive salary increases must be handled, he would be receiving what is considered a "Service Award Payment" which is not considered to be

regular compensation. Therefore, no retirement deductions will be withheld from this payment and it will not be included in any three year average for the purpose of calculating any potential retirement benefits.

Ms. Kiely-Becchetti reported on legislation S.1551 and H.2216 filed by MACRS to appoint to the PRIM Board one representative from regional or county retirement boards, and one representative from municipal retirement boards which invest the assets of their retirement system in the PRIT Fund.
